 - Once declared, you must maintain a 2.0 GPA from all ECON courses, or you will be dropped from the major.
 - You must earn at least a C+ in ECON 3010/3110, MATH 1210 (or its equivalent), and STAT 2120 (or its equivalent). You may only attempt those courses twice.
 - **You must complete ECON 3720: Intro to Econometrics (or ECON 4720) by the end of your 6th semester or you will be dropped from the major.**
- **Transfer Credit:** No more than two courses may be transferred post-matriculation. Students may **not** transfer ECON 3010/3110, MATH 1210 (or its equivalent), or STAT 2120 (or its equivalent) post-matriculation.
